

Advanced NLP Master Curriculum – EANLP



Participant Requirements

- NLP Practitioner Certificate
- NLP Master Certificate (EANLP or equivalent)

Duration

- Minimum of 65 training hours, including testing, delivered over 9 or more training days
- Optional supervision: 10 hours of individual or group supervision led by a certified NLP Master Trainer
- To deepen the acquired knowledge, 20 hours of group study within an organized study group are recommended

Delivery

- The training must be delivered by at least one certified NLP Master Trainer
- The lead trainer must conduct at least 80% of the total training duration

Training Assistance

- If necessary, the training may be supported by an assistant
- The assistant must have an appropriate qualification, at least at the EANLP NLP Master level or equivalent

Lead Trainer Qualification

- The trainer must have held EANLP Master Trainer certification (or equivalent) for at least 3 years
- Must have conducted a minimum of 3 NLP Practitioner and 2 NLP Master trainings

Preliminary Conditions

- Prior to the training, the training project, including promotional and informational materials, must be submitted for approval to the EANLP Training and Certification Committee. Trainers will receive a written response within 14 days
- The trainer must also submit their qualification documents to the committee prior to the start of the training

Training Group Size

- The training group must consist of at least six (6) participants

Participant Competencies & Certification Criteria

- Professional self-management, emotional stability, stress resilience, ability to compromise and make decisions
- Has personally integrated the presented content and is capable of using it responsibly

Minimum Content

Deepening of NLP techniques at the Master level, such as:

- Meta programs
- Advanced Timeline work
- Core Transformation
- Working with the “Inner Team”
- Social Panorama
- Advanced work with values and beliefs, etc.

Content may also include domain-specific applications, such as: healthcare, education, sports, business, and neurobiology. These enhance and complete the NLP methods at the Master level with specialized applications in professional contexts.

Written Assessment – Advanced NLP Master

- The written test is mandatory, verifying the transfer and integration of the minimum required content, and serves to ensure the quality of the training. It must demonstrate cognitive understanding and personal integration of the material
- The design and content of the written test are at the discretion of the certified NLP lead trainer
- Participant test materials must be archived for 3 years
- During this period, the EANLP Training and Quality Assurance Committee reserves the right to request full or partial access to the archive for quality control purposes

Practical Assessment – Advanced NLP Master

- The design and content of the practical test are at the discretion of the certified NLP lead trainer and should be aligned with participants’ life and professional experience
- The practical test allows graduates of the Advanced NLP Master Curriculum to congruently demonstrate integration of the learned NLP techniques

Advanced NLP Master Certificate Content

The Advanced NLP Master EANLP certificate must include the following details:

1. Statement of compliance with EANLP standards
2. Statement of compliance with the EANLP Advanced NLP Master Curriculum
3. Title: Advanced NLP Master EANLP
4. The area of application (e.g., healthcare, education, sports, business, neurobiology) may be specified within the body of the certificate, but not in the certificate title
5. EANLP seal
6. Duration of the training in days and hours
7. Calendar dates of the first and last training days
8. Signature(s) of the certified NLP lead trainer(s)
